



Leadership Development for Dental Profession Clinicians

FULLY FUNDED PLACES AVAILABLE!

The [Rosalind Franklin](#) NHS Leadership Programme is designed for clinicians and non-clinicians working within our health and care systems. The Rosalind Franklin is a 9-month leadership development programme for mid-level leaders aspiring to lead large and complex programmes, departments, services or systems.

The [NHS Leadership Academy](#) are providing places on this programme to offer leadership development opportunities and evaluate the suitability of our offers for clinicians working in the dental team, recognising the additional challenges faced accessing leadership programmes. These places are fully funded so there is no additional cost to the participant or employing organisation. By applying for a fully funded place, you are agreeing to the following terms and conditions:

1. A start date of **Monday 13th February 2023** and a commitment to the programme for 9 months with 8 mandatory development days (two introductory days, five further development days and a final workshop on the 20th September 2023). The programme is hosted on a virtual platform so you will need access to a computer or laptop. A total of 8 study days will be needed as well as time for reflection and self-directed learning.
3. Taking part in an evaluation process consisting of pre and post questionnaires and a one-hour virtual focus group

Supporting information

This offer is open to **B7 and above clinicians (or those with equivalent experience) working as Dentists, Dental Nurses, Dental Hygienists, Dental Therapists, Dental Technicians or Orthodontic Therapists, employed by or providing NHS commissioned services only.** As part of the application, you will be asked your place of work and why you wish to apply.

Before an application is made you **must have line manager agreement** to attend this course, commitment to undertake all the associated learning, and be able to forward on an email to demonstrate this before your place is confirmed. We have included a letter you may wish to send to your manager below. If you are offered a place on the programme and fail to attend, you will be liable to pay the cost of the programme.

All study days are mandatory, please find study day dates below. You will be allocated to either group A or B and both groups will attend the foundations and final Workshop together.

Over the 9 months, you will undertake 120 hours of online study over 6 modules. This will include work-based application, online discussions and a 5,000-word assignment which will be relevant to your role and learning.

Completion of programme

Successful completion leads to an NHS Leadership Academy Award in Senior Healthcare Leadership which is accredited and recognised as a Leadership Qualification across health and social care organisations.
