I want to become a specialist.

Currently there exist two pathways to becoming a registered specialist in Periodontics:

- Via application for a 'certificate of completion of specialist training' (CCST) following completion of a specialist training programme approved by HEE & GDC
- Via an assessed application to the GDC based on academic or research work.

CCST Pathway

Historically, trainees have been eligible for the award of a 'National Training Number' (NTN) upon application to Health Education England via the Oriel portal when applying for certain postgraduate programmes of study on approved courses. (https://www.oriel.nhs.uk/Web/Account/LandingPage)

A CCST would be awarded upon achieving:

- The completion of an approved training programme (as determined by the regional postgraduate dean)
- An approved qualification from one of the three surgical royal colleges (Royal College of Surgeons England, the Royal College of Physicians and Surgeons of Glasgow and the Royal College of Surgeons of Edinburgh)
- The necessary competencies in the Annual review of competency progression (ARCP) process.

As of September 2019, HEE are currently not awarding national training numbers of self-funded applicants pursuing 'specialist training' in Periodontics, Endodontics and Prosthodontics. The pathway does still apply for:

- Applicants applying for (salaried) NIHR Academic Clinical Fellowship (ACF) or Academic Clinical Lecturer (ACL) posts in Periodontics. These roles are advertised and funded based on local applications by approved providers and are recruited by competitive entry.
- Restorative dentistry trainees. These (salaried) roles are advertised and funded based on local applications by approved providers and are recruited by competitive entry. The ultimate purpose of these posts is the training of NHS Consultants in Restorative Dentistry, not in Periodontics, Endodontics and Prosthodontics.

Entry requirements:

As HEE have stopped awarding NTNs to self-funded Periodontics, Endodontics and Prosthodontics training programmes, candidates wishing to achieve specialist status are strongly urged to contact the respective institutions with regards to their individual entry requirements. It is also recommended that you contact your local postgraduate dental deans which can be found on https://www.copdend.org/letb/

Traditionally the requirements to enter specialist training have been as follows

- Completion of foundation training (DFT)
- Evidence of a period of training in secondary care (dental core training)
- Markers of completion of foundation training such as:
 - Membership of the Joint Dental Faculties (RCS England) RCS England will be discontinuing this soon
 - Membership of the Faculty of Dental Surgery (RCS Edinburgh and soon RCS England)
 - Membership of the Faculty of Dentistry (RCS Ireland)

Other useful criteria when considering your application include:

- Evidence of audit
- Demonstration of commitment to specialist training
- Experience/knowledge of research (does not necessarily have to be limited to periodontology) and critical appraisal
- Previous courses attended and shadowing / working with specialist colleagues
- Postgraduate qualifications and any publications
- BSP membership and attendance at local, regional, national and international meetings related to periodontology

Application for specialist status based on academic or research work

Applicants to the specialist lists who do not hold a Certificate of Completion of Specialist Training (CCST) or recognised qualification from an EEA member state are potentially eligible to enter the specialist lists on the basis of academic and research work (otherwise known as "assessed application".)

Advancing Dental Care: Education and Training Review

As a part of Health Education England's workforce strategy review in 2018, the 'advancing dental care' initiative completed phase 1 of their education and reform project. The aim of the project was to assess how health care professionals trained today are best served to support a patient's needs now and in the future in an effective and efficient way.

Phase 1 assessed the following:

- Who is being trained (nurses, technicians, dentists, hygienists, therapists, specialists)?
- How and at what point in their career people take up new learning.
- How training is funded.

Through assessment of research and discussion with healthcare professionals, 21 recommendations have been made to assess in phase 2 of the project. The review team has conducted further focused research to understand the current workforce; it's activity; and the newly qualified workforce's preferences and aspirations. Through engagement and options analysis, HEE are seeking to explore and develop more flexible training options, that build upon best practice. These are being piloted from 2020.

The outcomes of this process are as yet not fully clear but it is likely that pathways may become more flexible and that the allocation of training posts will be driven by planned estimations of current and future population demographics and statefunded healthcare needs relevant to each specialty across dentistry. This may mean a reallocation of salaried posts between specialties and geographically.

In summary, the future methods of training dental care professionals and specialists is likely to change. Accreditation of Performers of Level 2 complexity care

- Based on the 'Independent Review of NHS Dental Services' (Steele Review), it has been suggested that a pathway approach to dental care provision should be adopted as a part of contract reform and the future commissioning of training and dental services.
- The Department of Health has established advanced pathway groups for a number of specialities which defined case and procedural complexity at 3 levels.

 Levels 1, 2 and 3 are care descriptors which reflect a case in terms of procedural difficulty, patient modifying factors and competence required of a clinician to deliver care of that level of complexity.
- Level 1- skillsets and competencies that are covered by teaching and training in the undergraduate and dental foundation (FD) programme. Treatments which are not specifically defined in levels 2 or 3 are de-facto level 1.

Level 2 care is defined as procedural and/or patient complexity requiring a clinician with enhanced skills and experience who may or may not be on a specialist register. This care may require additional equipment or environment standards but can usually be provided in primary care. Level 2 case complexity maybe delivered as part of the continuing care of a patient or may require onward referral. Providers of Level 2 care on referral will need a formal link to a specialist, to quality assure the outcome of pathway delivery.

Level 3a and Level 3b care is that which requires specialist practitioner or consultant led care due to complex clinical or patient factors. This care can be provided in a primary care, dental hospital or in a secondary care setting depending on the needs of the patient and/or local arrangements which may include current training commitments.

Currently, local commissioners, Local Dental Networks (LDN), Managed Clinical Networks (MCNs) and Local Accreditation Panels (LAPs) are implementing processes for Accreditation of Performers of Level 2 complexity care. Those who believe they may be suitable for such accreditation are advised to contact their local NHS area team, LDN or MCN for information, as commissioning of posts is determined by availability and funding in a given region.
